Market rabbits will be identified on the second Wednesday in July with ear tags. Market Rabbits the exhibitor plans to bring to the fair for exhibit, show and sale, must be brought to the fairgrounds between **6:00 p.m. and 8:00 p.m. on the second Wednesday in July** to be tagged. Any Market Rabbit not brought to the fairgrounds at the designated time and identified, will not be eligible to sell in the Junior Fair Market Sale.

Exhibitors may tag-in 3 or 4 rabbits for 1 pen or 6 to 8 rabbits for 2 pens.
